## GENERAL MEETING DRECP

The draft Desert Renewable Energy Conservation Plan (DRECP) has been released for public review. The review period extends until January 9, 2015. The plan is the result of 5 years of effort by several state and federal government agencies to develop a plan for alternative energy development of 20,000 megawatts of renewable energy generation in the plan area by 2040, while providing for enhanced ecosystems for covered species and focusing energy development away from areas of greatest biological importance or sensitivity.

Our presenter will be Russell Scofield from the Sacramento office of the Bureau of Land Management. Russell is a wildlife biologist and coordinates the soil, air, and water programs for California BLM. Previously Russell has worked in several BLM management positions and served as the Department of Interior Coordinator for the interagency Desert Managers Group. Russell has worked for BLM twenty-one years.

This presentation will provide an overview of the program for those who missed the workshop at the Kerr McGee center, but will emphasize conservation efforts in our area. That will provide us an opportunity to ask many questions, but our comments will not be recorded. It will likely help us formulate comments to submit in writing.

### DECEMBER FIELD TRIP CHRISTMAS BIRD COUNT

Please join us once again for the annual China Lake Audubon Society Christmas Bird Count. Continuing with tradition, the count will be the first Sunday of the Count Period, December 14, from 0700 to 1700.

#### Valley Sightings – October 2014

Our first **Snow Goose** of the fall were at the ponds Oct 4 (TW, LA) which is expected.

Our first Ross's Goose of the fall was at the ponds Oct 31 (SLS) which is a couple weeks later than expected.

A Cackling Goose was at the ponds Oct 27-29 (TL).

A Horned grebe was at the ponds Oct 16 (SLS).

Western Grebes were noted on the 16<sup>th</sup>, 22<sup>nd</sup>, and 31 (SLS).

The eleven Common Gallinule at the ponds Oct 4 was a sign that they had a very successful breeding year (TW, LA). FOF for **Dulin** was from the ponds Oct 27 (TL).

FOF for **Bonaparte's Gull** was from the ponds Oct 16

FOF for Herring Gull was from the ponds Oct 22 (SLS). A Common Poorwill was in the Rademacher Hills Oct 27 (GW).

An Acorn Woodpecker was at the college Oct 30 (SLS) and another was in Ridgecrest Oct 1 (fide LL).

Our coot eating, pond visiting Peregrine Falcon was noted intermittently throughout the month (SLS).

A Pacific Wren was SW of Inyokern Oct 25 (PW).

A Golden-crowned Kinglet was in S Ridgecrest Oct 10 (DMcG).

Red-breasted Nuthatches were noted in Ridgecrest on Oct 16 (BB), at the college Oct 2 (SLS), and in Ridgecrest in late Sept (LL and L&SSu).

A House Wren was at the college Oct 2 (SLS). **Phainopepla** were at the college Oct 2 and 30 (SLS). The two **Townsend's Warblers** at the college Oct 30 became our late sighting date by two days (SLS).

A Yellow-breasted Chat was at the college Oct 2 (SLS). Two Vesper Sparrows were at the ponds Oct 27 (TL).

Our only report of Fox Sparrow was S of Inyokern Oct 28-31 (SLS).

Tan morph White-throated Sparrows were S of Invokern Oct 28 and at the college Oct 30 (SLS).

Golden-crowned Sparrows were S of Invokern Oct 28-31 and at the college Oct 30 (SLS).

A Blue Grosbeak was in Ridgecrest Oct 31 (BBu). While this is a late date, it is not unprecedented. We have three November records, the latest being Nov, 8 2009 at the college.

FOF for American Goldfinch was from Ridgecrest Oct

#### **BREEDING BIRD SURVEY OPPORTUNITY**

A North American Breeding Bird Survey (BBS) route is available for someone to take over. Due to pending personal changes, it is time to relinquish the route that I have run for the last 25 years.

The Breeding Bird Survey is an ongoing cooperative program sponsored jointly by the U.S. Fish and Wildlife Service and the Canadian Wildlife Service. During the 1960s, Chandler Robbins and his associates at the Migratory Bird Population Station (now the Patuxent Wildlife Research Center run by the USGS) in Laurel, Maryland, developed the concept of a continental monitoring program for all breeding birds. Its main purpose is to estimate population trends of the many species of birds that nest in North America north of Mexico and that migrate across international boundaries.

Breeding Bird Surveys are conducted during the peak of the nesting season, primarily in June, although surveys in desert regions (which is us) and some southern states, (where the breeding season begins earlier), are conducted in May. Each route is 24.5 miles long, with a total of fifty stops located at 0.5 mile intervals along the route. A three-minute point count is conducted at each stop, during which the observer records all birds heard or seen within 0.25 mile of the stop.

This route (the only BBS route in the area) starts at the intersection of Brown Road and Bowman Road in Inyokern; travels up Brown Road towards US395 to the powerlines; follows the powerlines to Iron Canyon; through Iron Canyon to Garlock Road; through Randsburg: and ending in Red Mountain. The survey starts at 5 am and finishes about 10 am. This is an easy route to survey as it is mostly homogenous desert (except for the "urban" stops in Randsburg and Red Mountain). I have typically run the route around Mother's Day in May. Good eyes and good ears are a requirement to perform the BBS survey.

The survey results are then fed into the USGS BBS database with the data available at their website (www.mbr-pwrc.usgs.gov/bbs/ <http://www.mbrpwrc.usgs.gov/bbs/> ). This website presents population change information for more than 400 species of North American birds, as estimated from the North American Breeding Bird Survey. Estimates of trend (intervalspecific estimates of population change), annual indices of abundance, and maps of abundance and population change for these species are presented for a variety of regions.

I will share my past results, tips and techniques, and drive the potential participant along the route to familiarize him or her with the stops. If you are interested or have any further questions, please contact me first by email (hallowellra@gmail.com).
